温湿度调节:

测试样品和香烟需要在23°C和相对湿度小于53%的环境中调节至少24小时.如果测试环境的温湿度与此不同,那么测试必须在离开上述环境的10分钟内进行.

 - c) 测试组合产生明火.
- 2. 如果初始的3个测试样品都通过测试, 则弹性填充材料通过测试.
- 3. 如果初始样品中多于1个样品未通过测试, 则弹性填充材料未通过测试.
- 4. 如果初始样品中有1个样品未通过测试, 重测3个附加试样.
- 5. 如果附加的3个样品通过测试,则弹性填充材料通过测试. 如果任何1个附加样品未通过测试,则弹性填充材料未通过测试.





Conditions of Issuance of Test Reports
