#### 1. 燃烧测试

根据加利福尼亚州第117号技术公告2013版（2019改版）第三部分:弹性填充材料测试.

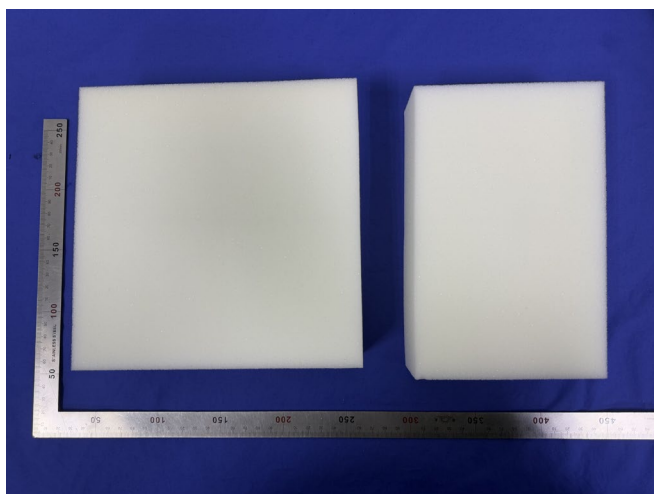
